

 d) Fulfill remaining hours via CPD Activities

 Total of 180 hours over 3 years

#### **Service Milestone**

PDP participants must also complete the service milestone and **remain employed with their nominating organisation for at least 6 months after the end of each PDP year** in order to receive the cash award.

## **Frequently Asked Questions**



## Q1) Can I seek <u>deferment</u> if I have valid reasons for not being able to complete the programme milestones for the year?

Deferments are granted on a case-by-case basis to participants who have valid reasons. For deferment requests, please write in (with supporting documents, if any) to <u>ecda pp@ecda.gov.sg</u> before the PDP year ends.

#### Q2) Will there be any penalty if I am withdrawn from PDP(Educators)?

Participants who are withdrawn from PDP(Educators) will not be eligible for any further cash awards. If you <u>have not received</u> any PDP cash award, you <u>can</u> be nominated for PDP(Educators) again 3 years later. If you <u>have received</u> the PDP cash award(s), you <u>cannot</u> be nominated for PDP(Educators) again.

#### Q3) My supervisor/nominator has changed, do I need to inform ECDA?

Yes, as we would like to keep your nominator informed of your PDP journey and provide important info, please send your new nominator's details (Name, Designation, Email, Contact) to <u>ecda pp@ecda.gov.sg</u>.

#### Q4) How do I amend/delete a CPD entry in ONE@ECDA?

As the CPD entries of all participants are locked while they are on PDP, please write in to <u>ecda pp@ecda.gov.sg</u> to request for assistance to untag the CPD entry before it can be amended/deleted.

## Year 1 Programme Milestone: Introduction to Compulsory Module\*

Professional Development Programme

Preschool Educators

#### [New!] Shaping Practices for Diverse Learners (15 hours)

- 1 full day and 2 half days course by NIEC, offered in both English and Chinese
- Observe and gather data on lesson design, classroom environment and interactions within the classroom for analysis
- Be equipped with skills on reflective processes for teaching & learning to meet the needs of children with different learning abilities through developmentally appropriate practices
- Introduction to the Universal Design for Learning (UDL) and its principles

Infant Educators/Early Years Educators

#### Observation and Planning for the Holistic Development of Infants and Toddlers (14 hours)

- 2-full day course by NIEC, offered in both English and Chinese
- Observe, understand and document the development, interests, needs and abilities of children from birth to 36 month
- Be equipped with skills to cater to the specific needs of the individual children and
- Effectively plan for purposeful experiences and collaborate with parents to support the young child's development and learning.

\*Participants who have completed the compulsory module prior to joining PDP are to complete one CPD course tagged to Stage 1 TSCs in-lieu.



## Year 2 and 3 Programme Milestone: Complete CPD Courses Tagged to Stage 1 TSCs

 Complete at least one ECDA CPD course tagged to Stage 1 Technical Skills and Competencies (TSCs) based on your Occupational Title (OT) annually

• 1 Stage 1 CPD course in Year 2 and another in Year 3

• Stage 1 TSCs are the prioritised TSCs of a job role.

• You can identify your job role based on OT via ONE@ECDA.





## Year 2 or 3 Programme Milestone: Introduction to Project

- Completion of at least 1 Project\* on PDP(Educators)
  - 4 months of project implementation within respective centre
  - Submission of Project Deliverables
- **Centre-Initiated Project (CIP)**: Provides participants the opportunity to apply their knowledge and skills within the centre and classroom


 Completion of pre-requisite course "Proposal Writing Skills for PDP Participants" (conducted in English and Chinese) is <u>compulsory</u> before embarking on the CIP

\*Note: Educators will have to take on the role of a Team Lead in the CIP to be awarded completion of the project milestone




## Year 1 to 3: Other Programme Milestones – 180 CPD Hours

- Participants are required to complete a total of 180 CPD hours over the 3 years on PDP(Educators), inclusive of hours from the previous programme milestones 1 – 3.



#### For Nominators (Operators)

- Verify your PDP participant's employment with the organisation as at 30 Sep of each year.
- Inform ECDA should the PDP participant resign from the nominating organisation.

• Apart from the programme milestones, participants are required to fulfil the service milestone (remain with nominating organisation for another 6 months after end of each PDP year) to be eligible for the annual cash award.

**For Educators** 

• Participants can be transferred/redeployed to other centres within the same nominating organisation.


### Example of How to Complete Programme Milestones




## Example 1: Completing more programme milestones in Year 1


#### **Example 2:** Professional **Spreading out programme milestones evenly across 3** Development years
